


Regations governing access to, and use of, the “OooOoO” skatepark by Koo Jeong A

The following rules govern the use of the “OooOoO” skatepark at Triennale Milano in Viale Emilio Alemagna, 6, 20121 Milano.

Safety manager’s rules

- The space can accomodate 150 people, with no more than 15 people on the ramp area;
- Access to the facility is allowed:
 - Starting from the age of 14 with the helmet requirement and the recommendation of the use of elbow pads and knee pads;
 - From children from 8 years (over) to 14 (not completed), access to the track is allowed with a helmet and a recommendation to use elbow pads and knee pads and only when supervision is guaranteed by skaters of Triennale Milano, therefore:
 - During the session of the Academy of Skateboarding (by reservation, for a fee. Information and calendar available on www.triennale.org);
 - When the triennale Milan Coach is present (from Tuesday to Friday from 3.00 pm to 7.30 om; on weekends and public holidays from 12.00 to 20.30, free access).
- The ramp area is for skateboarding only, which means the use of unsuitable equipment such as bicycles, roller-skates; kick scooters, motorized sports equipment, or toys is prohibited.
- Skateboards may only be used on the track and not in the surrounding areas;
- Watch out for other users; leave the track immediately through the exits provided if requested to do so by the staff;
- Ramps are not waiting areas and must be kept free of objects;
- It is forbidden to hang, climb onto, or lean over the parapets;
- In the event of an emergency, follow the instructions provided by the staff and by the emergency management team;



Furthermore, note that

1. Entry to “OooOoO” is subject to **acceptance of these regulations, to the signing of a disclaimer form**, and to consent by Triennale Milano staff, who reserve the right, at their sole discretion and without the need to provide any justification, to prevent anyone from entering the facility, even if previously authorised and registered.
2. Access to the facility does not entail any obligation for Triennale Milano regarding assessment of the user's physical fitness, experience, technical ability, or adequate preparation for skateboarding, with the consequent exclusion of any responsibility on the part of Triennale Milano.
3. In order to enter the OooOoO skatepark area, it is necessary to have read and signed these regulations and signed the disclaimer form, and to have presented an identity document to Triennale Milano staff.
4. **For minors, access to the OooOoO skate park is permitted only after the disclaimer form has been signed by at least one parent or guardian, with a copy of the identity document of the parent's signatory.**
5. Use of the facility is free of charge.
6. Everyone has a duty to keep the area clean. It is expressly forbidden to dirty the facility with any kind of litter, to write on or to soil the park or surrounding area. It is forbidden to damage or modify the park in any way.
7. It is forbidden to damage or modify the skatepark in any way.
8. Any unseemly, violent or rude conduct towards people or things is absolutely prohibited.
9. Triennale Milano reserves the discretionary right, without the need to provide any justification, to remove from OooOoO anyone who violates any of the aforementioned regulations, without prejudice to any other legal remedies.
10. Any violations of these regulations will be dealt with by Triennale Milano staff.
11. For anything not specifically mentioned in these regulations, reference is made to the legislation in force.
