# How to access public healthcare in Milano

The Italian National Health Service (SSN, Servizio Sanitario Nazionale) provides all citizens registered on the Italian territory healthcare coverage for: a general practitioner, pharmaceutical assistance, specialist medical practices, ER, surgery, rehabilitation etc.. In Italy, and particularly in the Milano area, public health care service provides very high-quality services.

**The service is provided for free if you enroll to the Service\*** or by paying a contribution to the expenses (the so-called ticket).

It is a good idea to get covered by public healthcare, even though you already have a private health coverage.

# **Step 1**

**Find your nearest ASST office**



**Azienda Socio Sanitaria Territoriale (ASST)** is the administrative entity that manages local health services competent in the area where you reside. The areas are called "*Municipi*" – i.e. the administrative enumerated zones of Milan.

Find out in which "*Municipio*" you live: ask your landlord, a neighbor, the pharmacist or any shop owner nearby.

Find the location and timetable of the "*Ufficio Estero*", the office handling the international procedures of your local ASST office.

# Find the Ufficio Estero or Ufficio Scelta e Revoca

If you miss to get in touch with the "Ufficio Estero" of your nearest ASST branch, you can alternatively look up for the "Scelta e Revoca" counters.

These are the counters in charge of assigning a general practitioner to citizens and residents.

**Procedures for EU Students**

# EU STUDENTS

*Students from European Union countries, the European Economic Area and from Switzerland*

## CASE A

If you stay in Italy for less than 3 months and you need to access the emergency room or **urgent health services** at an hospital, it is sufficient to show your valid EU ID and the European Health Insurance Card (EHIC / TEAM) of the State of origin.

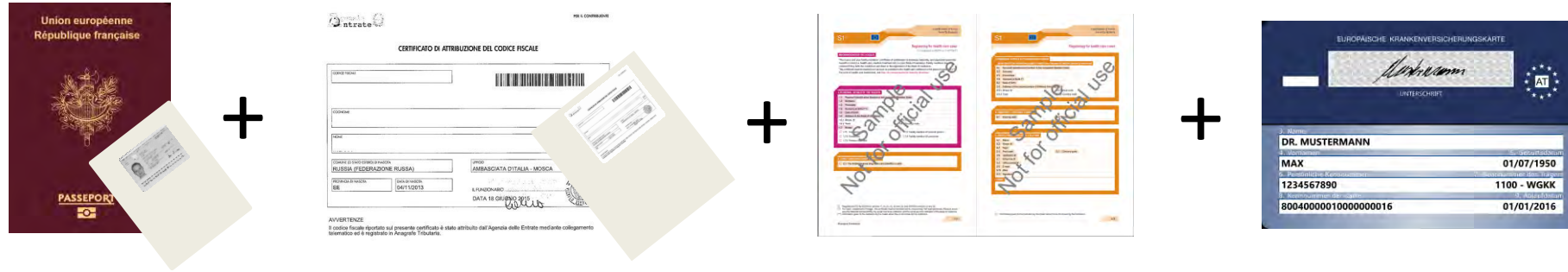
## CASE B

If you live in Italy for over 3 months and you wish to access additional health services (e.g. be assigned with a general practitioner and get discounted prices for medicines and therapies) you should better register with the National Health Service.

If you are moving from European Union countries, the European Economic Area and from Switzerland you can **temporarily transfer your health coverage** to take advantage of Italian public healthcare as an Italian citizen, **by obtaining S1 Form from your country of origin.**

If you don't have the S1 form with you, you are still eligible to subscribe for a Voluntary Registration by paying a fee.

# Enrol with S1 form

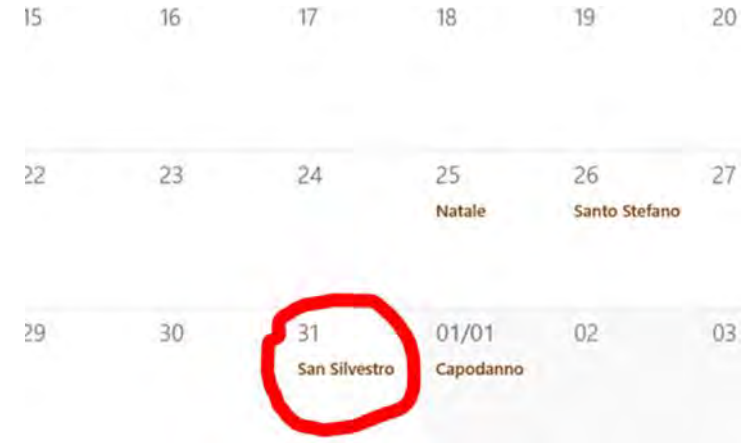


A. Go to Ufficio Estero / Scelta e Revoca counter with:

- a valid ID (and a photocopy)
- Tax code (and a photocopy)
- the S1 form and a self-certification of residence / domicile.

The office will retain the first sheet of S1 and the photocopies, and enroll you in the SSN. They will also assist you to choose a local general practitioner from a list. They will issue you a form called "Allegato 1" ("Annex 1") which must be shown as a health card at the time to request any health service.

# Enrollment expiration



Enrolment at the SSN **is valid for one year from the date of application.**

Should you stay longer you can follow the same procedure to renew your coverage as long as the period reflects the dates stated on the S1 form.

Please note: if you have a planned health treatment, e.g. for chronic disease, you need to ask your local authority in the country of origin for S2 form - Authorization to obtain planned treatment abroad.

**Procedures for ALL Students**

# The Voluntary Registration

The voluntary registration coverage **starts** from the date of registration **and expires on 31 of December** of the current solar/calendar year, no matter when you enroll.

The subscription is **never retroactive nor divisible**  
For students **the cost is €149.77 per calendar year.**

For students with dependant family members\*, **contribution is €387.34 per calendar year.** The contribution must be paid in one single payment.

Go to the nearest post office, get and fill in a blank "Bollettino Postale" payment form. The contribution must be paid on the postal account **379222**, in the name of (a favore di:) **"P.T. REGIONE LOMBARDIA"**, reason for the payment (causale) : **"iscrizione al SSN anno...[write the year of coverage]**

# Period of coverage

The voluntary registration validity period starts from the date of registration **and expires always on 31/12** of the current solar year and gives access to the general practitioner and health services only on the Italian territory.

The first application shall be done after January the 1st of the year in which you want to enroll.

**Skip-the-queue tip for renewals:** If you are already registered with SSN, renewals can be done in advance by repeating the same procedure and telling the officer that you are renewing the enrolment for the subsequent year.

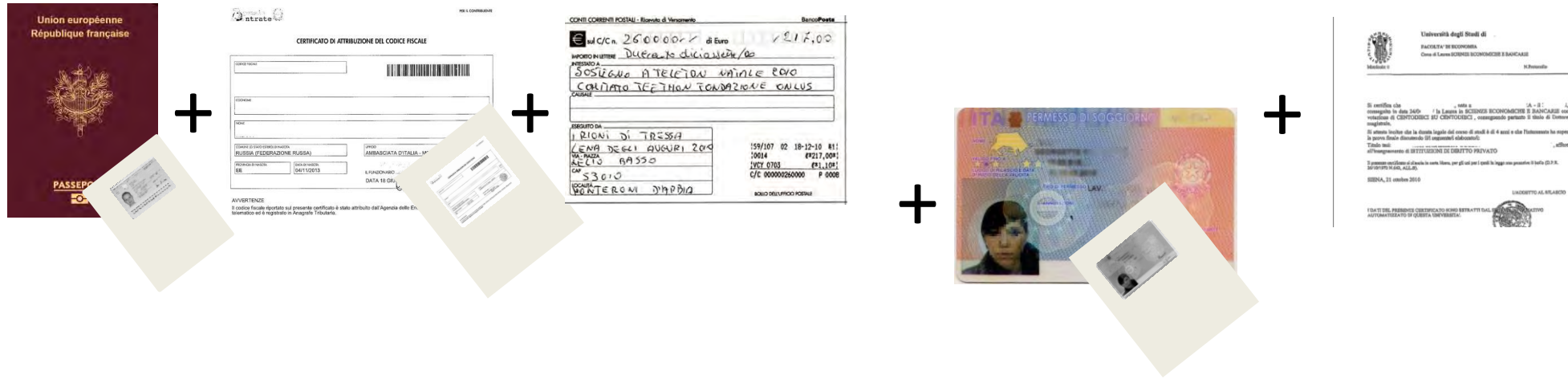

# Voluntary Registration with residence permit / EU students



**Students from European Union countries, the European Economic Area and from Switzerland:**  
Bring with you: tax code, valid identity document (both in original plus one photocopy) and a self-certification of residence / domicile, and receipt of payment of the contribution.

**Students from non-European countries already in possession of a residence permit for study:**  
Bring with you: passport, residence permit, tax code (both in original and one photocopy), certificate of enrollment in a course of study, and receipt of payment of the contribution.



# Voluntary Registration with residence permit appl. receipt



Students from non-European countries holding the application receipt of their residence permit for study will need to bring:

your passport, tax code, entry visa for study reasons, the receipt / certificate of having applied for a residence permit (all in original, plus one photocopy), certificate of enrollment in a course of study (issued by your university /institute), receipt of payment of the contribution

**\*The voluntary registration is issued valid for 3 months and it can be extended going again to the office, until obtaining the residence permit for study.** Once in possession of the actual residence permit, you may go to the office and have it registered: the deadline, then, will be set to 31/12 of the current year.

# Disclaimer

The voluntary registration with the SSN is **valid in Italy only** and **does not entitle** you to:

- a. Issue of the European Health Insurance Card (TEAM)
- b. Issue legal certificates required by bilateral agreements in force
- c. Issue of the certificate pursuant to art. 15 of Presidential Decree 618/80
- d. Issue of portable document S2 (high specialization care abroad)
